Over the past year, we have been evaluating the quality and value of our prescription drug program with Caremark.

What Do I Need to Do?

- As we approach the July 1 transition date, we strongly recommend that you ensure you have an adequate (minimum 30 days') supply of any medications you are taking on a regular basis. While we anticipate the transition to be smooth and efficient, it's always best to ensure you have an appropriate supply of your chronic medications on hand.
- Be on the lookout (as always) for information in the mail with the OE3 logo on it. OptumRx will place our logo on all of their materials, including your Welcome Booklet and new Participant ID Card.
- Check the Fund's website, www.oe3trustfunds.org. The website is a valuable resource for information about all of your health and welfare benefits and the communications about the OptumRx transition will be posted there as well.
