

SUMMARY ANNUAL REPORT

FOR PENSIONED OPERATING ENGINEERS HEALTH AND WELFARE TRUST FUND

This is a summary of the annual report of the Pensioned Operating Engineers Health and Welfare Trust Fund, E.I.N. 94-6096327, Plan No. 501, for the year ended December 31, 2020. The annual report has been filed with the Employee Benefits Security Administration, U.S. Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Insurance Information

The plan has contracts with Hawaii Dental Service, Hawaii Medical Service Association, Safeguard Health Plans, Inc., Kaiser Foundation Health Plan of Hawaii, Delta Dental of California, Kaiser Foundation Health Plan, Inc., UnitedHealthcare of California, Health Net, HMSA Health Plan, Union Labor Life Insurance Company, and Vision Service Plan to provide certain benefits incurred under the terms of the plan. The total premiums paid for the plan year ended December 31, 2020 was \$22,161,556.

Because they are so called "experience-rated" contracts, the premium costs are affected by, among other things, the number and size of claims. Of the total insurance premiums paid for the plan year ended December 31, 2020, the premiums paid under such "experience-rated" contracts were \$7,133,880 and the total of all benefit claims paid under these experience-rated contracts during the plan year was \$4,997,614.

Basic Financial Statement

The value of plan assets, after subtracting liabilities of the plan, was \$226,668,573 as of December 31, 2020, compared to \$202,001,601 as of January 1, 2020. During the plan year, the plan experienced an increase in its net assets of \$24,666,972. This increase includes unrealized appreciation or depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year, or the cost of assets acquired during the year. During the plan year, the plan had total income of \$144,580,878 including employer contributions of \$76,436,668, participant contributions of \$32,570,953, realized gain of \$410,891 from the sale of assets, earnings from investments of \$14,101,065 and other income of \$21,061,601 (reimbursements).

Plan expenses were \$119,913,906. These expenses included \$5,793,028 in administrative expenses and \$114,120,878 in benefits paid to or for participants and beneficiaries.

The charge to cover copying costs given above does not include a charge for the copying of these portions of the report because these portions are furnished without charge.
